Loan application form updates

June 27, 2017

As a reminder, effective June 30, 2017, we will be updating all of our Investment, RSP, and TFSA loan applications. The application forms will include updates due to recent changes to provincial pension legislation, anti-money laundering legislation, and Canada Revenue Agency reporting requirements, such as Common Reporting Standard (CRS), and other regulatory obligations.

Declaration of Tax Residency section (new):

This section will identify and report all persons who are residents, for tax purposes, in any country other than Canada or the United States to the Canada Revenue Agency (CRA). The new declaration of tax residence section will be included on all the applicable application forms. If the account is an entity account, the RC 519 form - Declaration of Tax Residence for Entities, should be completed for any non-individual accounts.

Application Information section (update):

For applicants who select "Retired" as their current occupation status, based on their previous employment, the "Industry /Type of Business" and "Detailed Occupation" fields are also required in order to complete the application.

Some additional CRS reporting requirements will be needed for 2018, but the specifics of the reporting requirements will be provided at a later date.

In addition, miscellaneous changes to field names and format to all of the forms will be made to ensure consistency among all our applications and forms.
