# **Account Agreement**

Throughout this Account Agreement, the terms "I", "me" and "my" mean the B2B Bank Intermediary Services Inc. (Group) Tax-free Savings Account holder. In consideration of B2B Trustoo (the "Trustee") and B2B Bank Intermediary Services Inc. ("B2BBISI") accepting this account, I acknowledge and agree that:
a) I have engaged my Dealer/advisor as my agent. B2BBISI is entitled to accept and act on any notice, authorization or other communication including by electronic transmission and telephone that it believes

- in good faith to be given by me or on my behalf by an individual or entity acting (or representing that it acts) in connection with this account as my Dealer or my advisor or on behalf of my Dealer or my advisor. B2BBISI is under no obligation to verify that my Dealer or my advisor or any individual or entity acting (or representing that it acts) is properly authorized to act as my agent or is otherwise authorized to act on my behalf.
- b) My Dealer, B2BBISI and the Trustee have different roles and responsibilities. I have read and I understand and accept the roles and responsibilities outlined below

#### Role of My Mutual Funds Representative

My mutual funds representative is responsible for working with me to understand and help me achieve my investment objectives by providing me with investment advice.

#### Role of My Dealer

Canadian securities regulations require that my mutual funds representative work under the authority of a dealer. My Dealer (the Introducing Dealer) and B2BBISI have entered into an Introducing/Carrying Dealer Arrangement. My Dealer is responsible for the opening and approval of new accounts and for supervising my mutual funds representative including ensuring that investments and trading activity in my account are suitable for me. Role of B2BBISI

B2BBISI, as the Carrying Dealer on this account, is responsible for trade execution and for settling trades (both of which my Dealer may do in certain circumstances) and custody of my cash and my securities. My investments are held by or in the name of B2BBISI with other qualified custodians. To protect my investments, fully paid investments are segregated from and cannot be used in the normal course of B2BBISI's business. B2BBISI is also responsible for issuing account statements and trade confirmations and for most tax reporting. Nevertheless, for mutual fund transactions, B2BBISI relies on the manager of the mutual fund to issue trade confirmations.

B2BBISI does not give investment advice, does not determine the suitability of my investments and is not responsible for and does not supervise any investment advice given to me by my mutual funds representative or my Dealer. Also, B2BBISI is under no duty to evaluate the appropriateness, accuracy or quality of any instructions received from me, my mutual funds representative, my Dealer or my employer for group accounts.

B2BBISI may pay a portion of its fees to my Dealer and my Dealer may pay a portion of its fees to B2BBISI Fees for carrying dealer services and for the trustee services B2BBISI arranges to be provided by the Trustee are paid by me in accordance with the B2BBISI Fee Schedule and/or are paid by my Dealer Role of the Trustee

The Trustee is the trustee of your registered plans. The Declaration of Trust included in the registered plan application form and in the account opening mailing is the contract governing any registered plans. The Trustee has appointed B2B Bank Financial Services Inc. as its agent, and may appoint other agents, to provide services to my registered plans in compliance with the Declaration of Trust.

- The Trustee and/or B2BBISI have the right to reject any of my instructions, or to sell any securities in this c) account for legal, regulatory or eligibility reasons.
- d) I am responsible for all commissions payable in respect of all trades in this account.
- e) My fixed income trades are valid until the end of the day, unless otherwise specified. I acknowledge that I am responsible for all trades placed by me, my Dealer or my advisor and I must pay for the trade at the time the trade is placed.
- f) B2BBISI will provide me with the applicable Account Fee Schedule upon their opening of this account. I will have up to 30 days from the date of account opening by B2BBISI to close this account without being charged the applicable fees as outlined in the Account Fee Schedule. For its annual fee, B2BBISI provides various account administration services, including custody of securities, maintenance of accounting records, collecting and remitting income, and issuing statements.
- I will pay the Trustee and/or B2BBISI any amounts owing to them and any fees as outlined in the Account Fee Schedule. In addition, the Trustee and/or B2BBISI can sell securities in this account or otherwise deduct g) from this account any amounts owing to them.
- h) B2BBISI may collect the annual and/or negotiated fee from the investments in my account. The fees will be collected based on the investments held in my account. B2BBISI has established a hierarchy of investments for collecting fees. The hierarchy is as follows where the fee will be collected from the named investment in ascending order:

# Tax-Free Savings Account Declaration of Trust

#### We, B2B Trustco, are a trust company incorporated under the laws of Canada with our head office located at 199 Bay Street, Suite 600 PO Box 279 STN Commerce Court Toronto ON M5L 0A2. You are the applicant/ holder as defined in the Income Tax Act, named in the B2B Bank Intermediary Services Inc. Tax-free Savings Account Application ("Application"). We will act as the trustee of a B2B Bank Intermediary Services Inc. Tax-free Savings Account ("Arrangement") for you on the following terms and conditions. You acknowledge that we have retained B2B Bank Intermediary Services Inc. ("Administrator") as our agent to perform on our behalf certain of our duties and responsibilities under this declaration.

- Acceptance and Registration: If we agree to act as trustee of your Arrangement, we will file with the Minister of National Revenue, in the form and manner and within the time prescribed, an election to register the Arrangement as a tax-free savings account ("TFSA") under the *Income Tax Act* (Canada) (such Act and the Regulations thereto, as amended from time to time, being hereinafter referred to as the "Tax Act"). We will also apply to register the Arrangement under any applicable income tax legislation in the province or territory of residence indicated by you in the Application. The Arrangement will comply with, and you will be bound by, the terms and conditions from time to time imposed on your Arrangement by the Tax Act and any other applicable legislation. If we decline to act as trustee, you or a Dealer (as defined below) will be
- notified and any amounts received by us as contributions will be returned. Purpose and Use: The Arrangement will be maintained for the exclusive benefit of the holder (as defined 2. below), disregarding any right of a person to receive a payment out of or under the Arrangement only on or after the death of the holder. Contributions accepted by us for your Arrangement will be used, invested and applied for the purpose of the making by us of distributions (as defined below) under the Arrangement to the holder in accordance with the Tax Act. While there is a holder of the Arrangement, no person other than us and the holder shall have any rights under the Arrangement relating to the amount and timing of distributions and the investing of monies. In this declaration: "holder" means, until your death, you, and at and after your death, your validly designated successor holder (as described in Section 12 hereof), if any; and "distribution" means any payment made under the Arrangement in full or partial satisfaction of the holder's
