- · One ticket per trade.
- Cannot be used to trade equities on accounts held at B2B Bank Financial Services Inc. and B2B Bank Intermediary Services Inc.
- Cannot be used for trades that are executed at other Dealers and whose settlement is either a DAP (Delivery Against Payment) or RAP (Receipt Against Payment). For settlement purposes, a copy of the Dealer's contract is required.

The Trade	Required fields: (A) - (E), (G), (I), (J) & (L) Optional fields: (F), (H) & (K)	 Contact the Trading Desk for symbol or exchange information as well as real-time quotes and commission rates. All trades are "Any Part" orders unless indicated as "All or None". All or None Special Term Order - Trader must buy/sell all the shares indicated or none. There are no "partial fills" under these types of orders. Good Till Cancelled or Day If no option is given the default will be "Day". CFO (Change Former Order) resubmit ticket with new price or terms.

4. Authorization	All	 Only licensed Investment Dealers can authorize and complete the Equity Trade Ticket. Client signature is optional for accounts with an introducing Dealer, but required for Direct Trading accounts.
